

1 DRAFT PROPOSED SUBSTITUTE FOR COUNCIL RESOLUTION NO. 2013-08

2 BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF DOVER, IN COUNCIL MET:

3 That the Mayor and Council have determined that the Charter of the City of Dover should be amended to 4 provide a definition and procedure for excused absences and change the duration of a vacancy for election

5 purposes from the term expiration date to the next election date. Therefore, the Mayor and Council of the

6 City of Dover respectfully request the General Assembly of the State of Delaware to amend Article II -

7 Mayor and Council, Section 13. - Vacancies; forfeiture of office; filling of vacancies, of its Charter, which

8 amendments, if adopted by the General Assembly, would be as follows:

- 9 CITY OF DOVER CHARTER ARTICLE II MAYOR AND COUNCIL
- 10 Section 13. Vacancies; forfeiture of office; filling of vacancies
- (a) Vacancies. The office of a council member shall become vacant upon the member's death,
 resignation, or removal from office or forfeiture of office in any manner authorized by law.
- 13 (b) Forfeiture of office. A council member shall forfeit that office if the council member:
- 14 (1) Fails to meet the residency requirements,
- 15 (2) Violates any express prohibition of this charter,
- 16 (3) Is convicted of a crime involving moral turpitude, or
- 17 (4) Fails to attend three consecutive regular meetings of the council without being excused by the council.

- 19 (a) Procedure for Excused Absences. Council members shall be required to contact the City 20 Clerk's office no later than 4:00 p.m. of the day of the meeting requesting to be excused 21 from the meeting and stating the reason for such absence. Failure to comply, except in 22 cases of emergency, shall result in an unexcused absence. The Clerk shall inform the 23 Council of the reason for the member's absence. Upon passage of a motion by a majority 24 of the members present, the absent member shall be considered excused and the Clerk will 25 make an appropriate notation in the minutes. If the motion is not passed, the Clerk will note in the minutes that the absence is unexcused. 26

27 28	(b) Excused Absences. Excused absences shall be limited to those which meet both of the following requirements:		
29	(1) The absent member must have informed the City Clerk's Office of their intended		
30	absence prior to the scheduled meeting. Failure to inform prior to the meeting shall		
31	result in an unexcused absence, unless extenuating circumstances prevent advance		
32	notice, and		
33	(2) The absence is due to one of the following:		
34	(i) A death in the family		
35	(ii) Family or personal illness		
36	(iii) City-related business		
37	(iv) Personal leave (limited to one per fiscal year)		
38	(v) Emergency		
39	(vi) Decision by member's supervisor in employment		
40	(vii) Required military service		
41	(vii) Inclement weather		
42	(viii) Accident		
43	(ix) Scheduled vacations		

In the case of any such vacancy or of any vacancy created by death, resignation or otherwise, for which said
 if the date of the vacancy shall be is less than six months *from the next election* in duration, the office

45 *if the date of the vacancy* shart be is less than six months *from the next election* in diffation, the office 46 shall remain vacant. If *the date of the* such vacancy should be is in excess of six months *from the next*

47 *election* in duration, a Special Election shall be held to fill such vacancy, this Special Election to be held

48 no sooner than 30 days and no later than 60 days after from the date of the vacancy, .but said special

49 Election to be held no later than 60 days after the date of the vacancy. If council fails to call for a

50 Special Election, the Special Election shall be called by the Election Board.
