

City of Dover Summer Cleanup Program



Due to COVID-19, the City's Spring Cleanup Program was postponed.

See information below regarding the next scheduled cleanup program supported by the City.

The City of Dover has designated **August 10 - 21, 2020** as **SUMMER CLEANUP**. It is intended to replace the traditional Spring Cleanup Program. The City encourages all residents in the City of Dover to cleanup and beautify their premises during this time. **SUMMER CLEANUP** is designated for residential trash customers of the City of Dover and does not apply to commercial accounts.

<u>SUMMER CLEANUP</u> items should be put out the same day as your regular trash day for pick up. Bulk yard waste and bulk household items should be put out following the schedule provided on the opposite side of this page. We ask residents to set out trash by 7:00 a.m. on the day of collection. Trash and bulk items can be put out <u>after 7:00</u> <u>p.m.</u> on the day before your scheduled trash collection day. There will be <u>NO CHARGE</u> during <u>SUMMER CLEANUP</u> for bulk items.

Loose leaves along the curb or in the alley will be collected during **SUMMER CLEANUP**, weather permitting. Leaves cannot be in bags or contain litter or yard waste which includes sticks (no foreign objects or debris permitted). Such items will not be collected. The schedule for leaf collection will be the **day after** your regular trash pickup day. (Leaf collection for Friday's trash route will be on Monday, August 10 & 17, 2020.)

The City of Dover <u>WILL NOT</u> pick up items such as cement, tires, bricks, sand and concrete blocks. If you have questions regarding particular items for pick up please call the Department of Public Works at 736-7025.

<u>FOLLOWING SUMMER CLEANUP</u>, all waste collection will follow standard operational guidelines (see opposite side of page). Any waste put out before 7:00 p.m. the evening before scheduled trash collection will be subject to fines. Any bulk piles larger than 4'x4'x8' will be subject to additional charges in order to be collected.



City of Dover Residential Trash Collection Guidelines



Trash should be placed out for pickup on collection day by 7:00 a.m. or the prior evening after 7:00 p.m.

For areas serviced via an automated trash truck: <u>ALL</u> household trash <u>MUST</u> be bagged and placed in the 90-gallon container provided by the City (<u>NO</u> trash on top of cans). Please place container at least 3-feet away from cars, fences, mailboxes, etc., facing the correct direction (as seen in the photo below). For areas designated as hand trash only (not possessing a 90-gallon City of Dover trash can), please contact the Public Works office at 302-736-7025 for specific guidelines applicable to you.





YARD WASTE

ALL loose yard waste material, including grass clippings, MUST be placed in a privately owned 35-gallon or less plastic container (limit 5 containers). Yard waste containers are picked up on the regular weekly schedule. Do not place yard waste in a plastic or paper bag. Do no mix yard waste with household trash; if mixed the City will not collect. Filled yard waste containers are not to exceed 75-pounds in weight.





BULK WASTE

Bulk waste shall be neatly stacked at the curb. Do <u>NOT</u> place bulk piles directly under power lines or against buildings or fences. The maximum size shall be a **4'** wide, **4'** tall, **8'** long area.

Bulk yard waste consists of yard waste that will not fit within the 35-gallon container. **Bulk yard waste** is collected on the same day as your recycling collection.

Bulk household waste (furniture, large appliances, rugs, etc.) is collected on the week opposite your recycling collection.

SORRY, WE CANNOT COLLECT TIRES, CONCRETE, BRICKS, CHEMICALS OR OTHER HAZARDOUS WASTE.
